Dr. Sullivan opened up the meeting by stating the administrative assistant is unavailable tonight because of illness, along with two board members. Dr. Sullivan states the approval of minutes will be put on hold.

The meeting for the Emergency Dispensing Site was on 09/13/2023, and Dr. John Sullivan and Fire Chief Mark Sadowski attended via Zoom.

Dr. Sullivan speaks of data received from the sewage reports. 80% of the variants detected in the most recent data is XBB. The XBB variant is the same variant used for the latest Covid booster. Dr. Sullivan states monitoring the sewage reports will prove to be very useful in the coming months.

Amelia Houghton speaks on the Flu Clinic proposal. Ms. Houghton has confirmed there will be a Flu Clinic scheduled in the coming days. Ms. Houghton states there is very little Flu and some Covid cases. Bob Barrell asks if there are Covid test kits available to be distributed to the residents this year. Ms. Houghton states that if there is an outbreak, we are able to reach out to the state, but at this time, there is not Covid test kits available.

Soloe Dennis reports on twelve health inspections conducted with no violations found. Mr. Dennis mentions the first Regional Alliance meeting with three Town Administrators under the Central MA

week. Mr. Dennis states that Environmental Specialist (Title 5), Phil Leger, has just renewed his contract with the Health Alliance for another 12 months. The Alliance was asked to provide Title 5 reports moving forward. Dr. John Sullivan speaks on West Nile Virus and EEE in the West Boylston area.
