Mr. Chase reviewed the report prior to the meeting; he briefly discussed with board this evening.

At 6:00 pm, Ms. Eaton made a motion to open the meeting. Mr. Haarmann seconded. All in favor. Mr. Chase called the meeting to order.

### Public Hearing, New England Power Company (d/b/a National Grid), Request for Determination of Applicability, for the O141/P142 Flyover Switch Installation Project at 196 Temple Street, West Boylston, MA:

(Jason Tome represented, on behalf of New England Power Company). (Ms. Eaton read aloud the public hearing notice). Showing the board a map of the site, he explained that the proposed project was to install flyover switch structures to allow control of electricity along the existing electrical circuits during future operation and

maintenance activities. He noted that the reason for this RDA is that the flyover switch structure would be within 200 feet of the buffer zone of a stream. He described that the installation process involves making of a five-foot diameter hole, 13-feet deep, with 20 square feet of proposed permanent impact of the flyover switch structure. He showed the board potential temporary impacts on the map to wetland buffer and stream buffer. Mr. Tome replied to Mr. Chase that they already have existing roads in place; they are highlighted on the map and he said that they lead to the flyover switch structures. He responded to Ms. Eaton that there is an existing power line 83 is just north of it, and that will remain but this will just be an add-on to the line. Mr. Chase added that the others are just manual terminals but this one will be remote.

Mr. Tome showed the board a photo of what the flyover structure will look like. He noted the 20 square feet of permanent impact. He noted that the work will be in compliance with National Grid's Environmental Guidance Manual (EGE 303 ME), which has best management practices to minimize any adverse effects on any of the resources. There will be an environmental inspector who will conduct periodic inspections for compliance with the EGE 303 ME. He asserted that permanent impacts will be minimal to the 200-foot resource area and any remaining disturbances will be temporary, therefore they are requesting that the Conservation Commission issue a negative determination for this project.

With no further comments or questions, Mr. Haarmann made a motion to issue a negative determination. Ms. Eaton seconded. All in favor.
